

Copyright Policies for Rethinking Clinical Trials®: A Living Textbook of Pragmatic Clinical Trials

Original Content Created for the NIH Pragmatic Trials' Collaboratory Living Textbook

All original content created for the NIH Pragmatic Trials Collaboratory's *Rethinking Clinical Trials®: A Living Textbook of Practical Clinical Trials* (the "Living Textbook") will be made freely available to the public, without any restrictions other than those noted in the Living Textbook copyright notice (please see Appendix 1: Copyright Notice).

All contributors of original content must agree to sign a Publications Agreement acknowledging this and releasing ("dedicating") their copyright to the public domain. Contributors are responsible for ensuring that the content they provide (in its original state as received by the NIH Collaboratory) does not infringe upon any other party's copyright and does not contain material that could be construed as libelous.

Contributors are also responsible for identifying any relevant conflicts of interest, financial or otherwise, that they may have. Contributors also acknowledge that any original material they provide is subject to editing, revision, and periodic updating, which may include the addition or removal of material by NIH Collaboratory staff or other NIH Collaboratory contributors.

Contributorship Definitions

Living Textbook contributors will be recognized as follows:

- **Contributor:** Subject matter expert who contributes substantively to the development or revision of the content. Drafts the content and/or reviews and revises it for important intellectual content. The Contributor is accountable for the accuracy of the work.
- **Contributing Editor:** Professional science writer/editor (NIH Collaboratory support staff) who collaborates with Contributors (subject matter experts) to perform background research and/or make substantive contributions to developing or revising content, subject to review and approval by the Contributor.

Other contributions that do not fit into one of these categories may be recognized in the acknowledgements.

Adapted Content Hosted on the NIH Collaboratory Living Textbook

Contributors of content hosted on the NIH Collaboratory "Living Textbook" are responsible for observing applicable standards for the re-use and adaptation of previously published materials and third-party data or communications, as described below:

Attribution of Content

Any content that is cited, quoted, excerpted, or adapted for use by contributors to the NIH Collaboratory must include [minimal attribution elements](#) such as those stipulated by the Uniform Requirements of the International Committee of Medical Journal Editors.

Permission to Use Copyrighted Material

Content contributors are also responsible for obtaining any necessary permissions for the re-use of [copyrighted](#) content from the holder of the copyright. This includes, but is not limited to, the following examples:

- Figures, illustrations, videos, sound recordings, charts, or tables taken from published journal articles, textbooks, websites, broadcasts, or other sources;

- Unpublished data or communications provided by third parties.

Appendix II: Tips on Obtaining Permission to Use Copyrighted Material

When adapting or re-using copyrighted material, permission must be obtained from the *copyright holder*, which may or not be the author(s) of the material.

Journal websites typically include information on how to obtain permissions to re-use published content; in many cases, publishers use a clearinghouse service such as the [Copyright Clearance Center](#). Permissions available through such services can be obtained by filling out a web form and (when applicable) paying a fee for the permission, which is typically made available immediately. An additional notification letter to the author(s) of the work being adapted may be appropriate as a courtesy, but is not itself sufficient to secure permissions for re-use in any case where the author is not the sole holder of copyright.

In cases where copyright is not transferred to the publisher, permission must be sought from the original author or other copyright holder.

Adapting Material Published under Creative Commons Licenses

Material published under Creative Commons (CC) licenses, such as some open-access journal articles, can be adapted and/or reused according to the specific stipulations of the CC license. See [descriptions of available CC licenses](#) for more information.

Adapting Material in the Public Domain

Copyright does not apply to works that are in the [public domain](#) in the United States. Such material can be freely adapted and used without permission, although it must be appropriately attributed, as described above. Work in the public domain includes (but is not limited to) the following examples:

- Works for which the term of copyright has expired;
- Works produced U.S. federal government employees; and
- Works released (“dedicated”) to the public domain by the copyright holder.

Copyright is typically awarded for a finite period of time, but the length of that period depends upon variables such as when the work was created and/or published and the national and international laws that may apply.
