# Stakeholder Engagement Core

## Statement of Purpose:

- The **Stakeholder Engagement Core** provides the forum within which a wide range of stakeholders can bring their different perspectives and expertise to the work of **overcoming barriers to the transformation to a learning health care system.**
- The external **Stakeholder Advisory Group (SAG)** includes representation by patients, clinicians, provider organizations, payers, policymakers, life science industry, researchers, and research funders

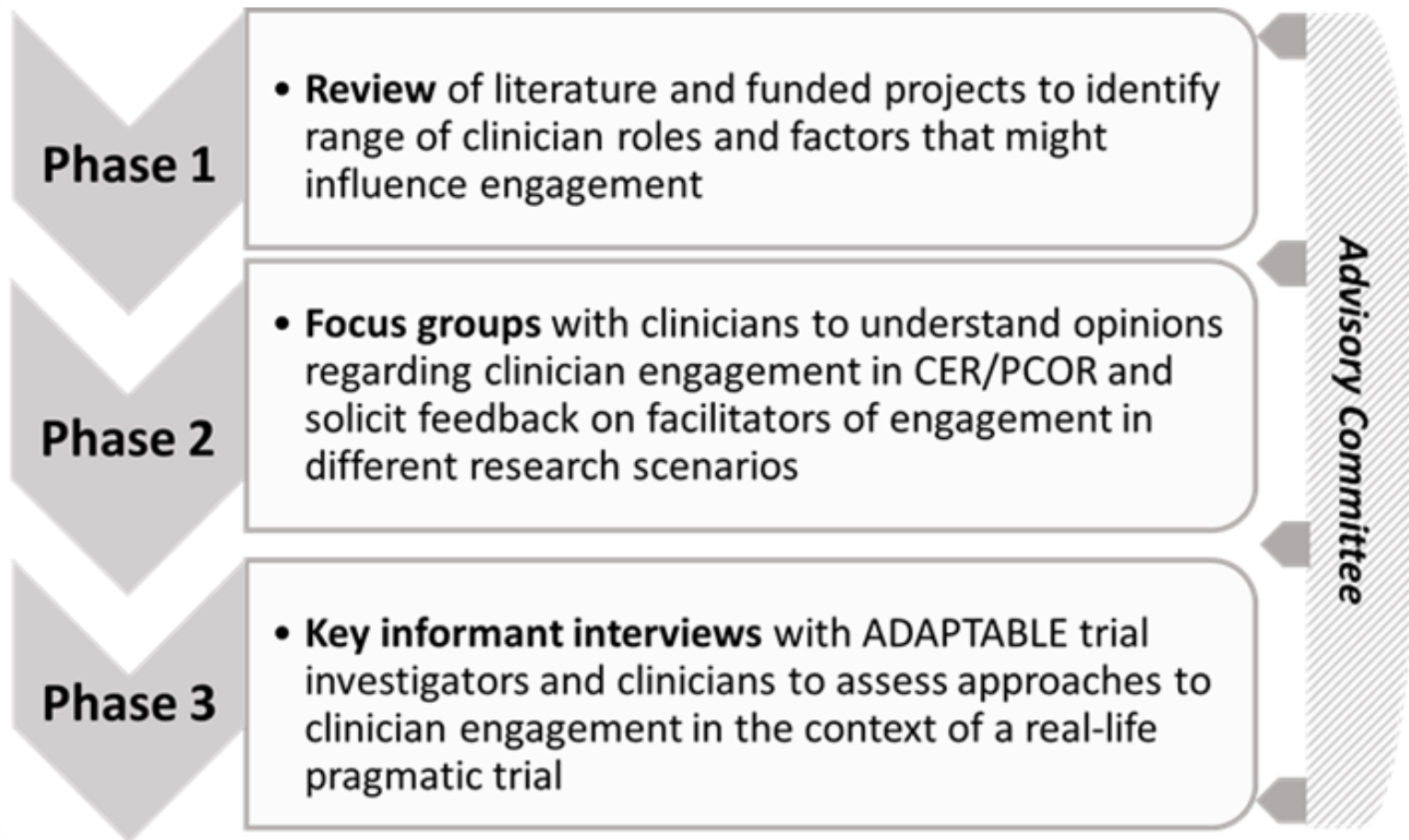
# Ongoing Focus on Clinician Engagement

- **1st SAG Meeting - May 2013**
  - Stakeholders cautioned that the notion that learning will lead to better patient care is not in itself sufficient motivation for broad and sustained participation and support from health systems, clinicians and patients.
- **2nd SAG Meeting – May 2014**
  - Discussion focused on strategies for enhancing patient and clinician engagement, drawing on the experience of several relevant projects and initiatives (*Moloney RM, Tambor ES, Tunis SR. Patient and clinician support for the learning healthcare system: recommendations for enhancing value. J Comp Eff Res. 2016;5(2):123-128.*)
- **Qualitative Study of Clinician Engagement in Collaboratory PCTs**
  - Key informant interviews conducted June-September 2015  
(*manuscript in development*)

# Proposed Project

- Qualitative study to develop a framework for more effective engagement of clinicians in CER/PCOR
- Proposed Specific Aims:
  1. Define the range of roles clinicians play in CER/PCOR conducted in clinical settings.
  2. Evaluate the conditions or factors at the personal, practice setting, and health system level that are most likely to influence clinician participation across a range of possible roles in CER/PCOR.
  3. Develop a framework defining strategies and facilitators to promote clinician participation according to potential roles in CER/PCOR.
