

Patient-Centered Outcomes Research Institute – PCORI

- Non-profit, governed by a Board representing patients, caregivers, payers, providers, health systems, and other stakeholder
- Supports patient-centered, comparative clinical effectiveness research (CER) via funding support of research projects, methods and infrastructure development, and engagement efforts
- Requires diverse stakeholder engagement throughout research development, conduct, dissemination, and uptake
- Focuses upon compelling clinical choices among effective or widely-used interventions, overall and by subgroups
- To date > 2000 funded research and related projects with awards ~\$4 billion



Overview of Major PCORI Initiatives in Health Equity



- Engagement emphasis on diverse, patient-centered, and trustworthy engagement throughout research via capacity-building + novel research science on engagement approaches
- Health Systems Implementation Initiative: health system participants serve DEI populations
- Infrastructure efforts to expand PCORnet geographic, racial, and ethnic coverage + AHRQ-PCORI scientist CER training in safety net, community-based organizations, FQHC, and minority serving institutions (LHS E-STaR)
- PCORI Application Review processes use purposeful DEI planning and required training
- Research
 - Guided by diverse stakeholder input on topics and approaches including PCORI's Advisory Panel on Clinical Trials
 - "Partners" funding of joint projects with community organization partners for health equity research
 - Supplementary funding offering to increase diversity and/or advance health equity

"Partner" PFA: Partnering Research and Community Organizations for Novel Health Equity Research



- Emphasizes health equity research done in **full partnership with communities** with strategies to address social determinants of health AND health systems strategies to address disparities
- Requires core leadership with dual PIs one research, one from a community organization
- Community organizations serve in leadership roles and participate in critical decision making alongside research organizations
- \$63 million in funding available with individual awards up to \$21 million total costs

Supplemental Funding to Support Diversity and Advance Health Equity




- Invitation-only funding opportunity to enhance efforts of existing PCORI awards in CER
- Supplemental Funding made available to selected PCORI-funded comparative clinical effectiveness research projects to increase diversity and/or advance health equity
- Allows options such as
 - Addition of sites, recruitment methods and/or strategies that enhance the diversity of study participants
 - An increase in the sample size to increase diversity/representativeness and improve heterogeneity of treatment effect analyses
- \$30 million in funding available with up to \$2 million in direct costs per supplement request, capped at 20% of original total contract budget
